# **Planned Parenthood Selling Body Parts of Aborted Babies**

A new video shows the top doctor for Planned Parenthood describing how the abortion business sells the bodies of aborted babies. The undercover footage reveals, in the words of Planned Parenthood's Senior Director of Medical Services, Dr. Deborah Nucatola, that selling body parts is business. She calmly eats her salad as she tells two actors posing as buyers from a human biologics company, how Planned Parenthood charges per specimen and uses illegal partial-birth practices to obtain sizable parts.

Assuring the undercover actors she is good at what she does, Nucatola explains, "We've been very good at getting heart, lung, liver, because we know that, so I'm not gonna crush that part, I'm gonna basically crush below, I'm gonna crush above, and I'm gonna see if I can get it all intact."

Planned Parenthood has, predictably, denied that this occurs, despite the video confession of its top doctor. The organization claims that it may 'donate tissue' for 'humanitarian' purposes. That's some serious spin on profiting from body part sales.

As of print time, at least three states have opened investigations in the wake of this revelation. Additionally, the U.S. Congress will be conducting its own review of the Planned Parenthood abortion business following this shocking video. Troy Newman, President of Operation Rescue, has promised more videos on the subject in coming weeks that will lay bare the lies and cover-ups of Planned Parenthood.

# Legislative Update

## **Confirmation of Pedro Cortes as PA Secretary of State**

The PA Senate voted 31-18 to confirm Pedro Cortes as PA Secretary of State on 6/2/2015. Cortes was Secretary of State during the Rendell Administration, and under his leadership the Department of State did nothing to stop abortionist Kermit Gosnell from conducting abortions at his "house of horrors" in Philadelphia, despite continued reports from the public. In fact, Gosnell's abortion facility was not inspected for 17 years. Gosnell was eventually convicted of the murders of three full-term babies and of causing the death of a female patient.

The three PA Senators who represent Butler County - Scott Hutchinson, Donald White and Elder Vogel, Jr. – all voted against Pedro Cortes' confirmation (pro-life position). Please call or write your State Senator to express your thanks for this pro-life stance.

## **Governor Wolf and Alternatives to Abortion**

Governor Wolf's proposed budget contains a ZERO percent increase in PA's funding for Alternatives to Abortion, the program that administers Real Alternatives and that supports Lifeline here in Butler County.

This year has seen a record number of doctor-assisted suicide bills introduced across the United States, including bills introduced in Pennsylvania. Senate Bill 549 and House Bill 943 were both introduced in Spring 2015; so far, they are still in committee.

## "Dismemberment Abortions"

Two governors (Oklahoma and Kansas) have signed bills in Spring 2015 to ban "dismemberment abortions" – any abortion where forceps or a similar instrument is used to cause the death of the unborn child by purposely dismembering and extracting the baby one piece at a time from the uterus. Passage of this bill essentially prohibits all late term abortions.

The legislation passed in these 2 states is based on model legislation written by the National Right to Life Committee, known as The Unborn Child Protection from Dismemberment Abortion Act.

Again, please contact our PA legislators, to ask them to introduce similar legislation in PA.

#### Pain-Capable Unborn Child Protection Act

This bill recently passed in the US House of Representatives and has been introduced in the US Senate. We are awaiting a vote in the Senate this Summer.

The Pain-Capable Unborn Child Act would rule that any abortion after the unborn child feels pain (20 weeks gestation) is illegal. Debate on this legislation will be a tremendous opportunity to educate millions of Americans about the humanity of the unborn child and the pain it feels in an abortion.

Fetologists agree that 20 weeks gestation is the time when the baby's pain system is fully operational. There are only 7 countries that allow widespread abortions after 20 weeks, including China and North Korea; we need to end this practice in the United States.

We all should contact our US Senators and let them know that we want them to vote YES on this bill and YES to an override vote, if President Obama vetoes this legislation:

## 40 Days for Life

What happens during 40 DAYS FOR LIFE? Men and women stand outside an abortion facility, holding a sign that says Pray to End Abortion. In Pittsburgh, we stand at the Planned Parenthood facility on Liberty Ave. Since the first 40 Days campaign in Texas in 2004, the movement has spread to 579 cities in 30 countries. The campaign has documented:

- 10,000 babies whose lives have been saved by preventing abortions
- 60 abortion facilities have been closed
- 118 abortion workers have converted to being Pro-Life
- Up to 75% "no shows" of abortion appointments, on days that Pro-Lifers are outside praying
