## Planned Parenthood - Time to Defund It!

Ever since the Center for Medical Progress released its undercover videos showing Planned Parenthood executives and employees admitting to selling baby parts, Planned Parenthood has been on the defensive. Desperate to shift the focus away from its involvement with abortion, Planned Parenthood and its supporters have been clamoring that abortion only comprises 3% of its total services provided to women. The drumbeat has been that any efforts to defund Planned Parenthood are political and deny women the vast majority of necessary services that the organization provides. Planned Parenthood has been quick to cite a number of recent polls purporting to show that the public is buying into that narrative and generally not in favor of cutting off taxpayer dollars to it. Wrong on both counts.

### What Does Planned Parenthood Do?

First, the claim that abortion only comprises 3% of services provided is incredibly misleading. It only works if each "discrete clinical interaction" is counted, so surgical abortion ends up getting counted the same as dispensing birth control or administering a pregnancy or STD test. In fact, about 12% of women who receive any service from Planned Parenthood end up getting an abortion in the same year.

National Review editor Rich Lowry has noted how ludicrous this 3% figure really is by offering a couple of analogies:

*The sponsors of the New York City Marathon could count each small cup of water they hand out (some 2 million cups, compared with 45,000 runners) and say they are mainly in the hydration business.*

*Or Major League Baseball teams could say that they sell about 20 million hot dogs and play 2,430 games in a season, so baseball is only .012 percent of what they do.*

Moreover, abortion is where the organization makes its money. Though Planned Parenthood does not disclose what it makes from abortion, we do know how many abortions it performs and have a cost range for each type of abortion procedure (provided by Planned Parenthood). Even using the most conservative of calculations, Planned Parenthood pulls in close to \$100 million annually from abortion.

Finally, with regard to the first point on services provided, Planned Parenthood's "pregnancy services" are dominated by abortion. Consider that:

- The number of abortions Planned Parenthood performed from 2000 to 2011 increased from 197,070 to 333,964, more than doubling its share of the abortion market from 15 percent in 2000 to 32 percent in 2011, the latest year for which national data are available.

- Planned Parenthood affiliates perform about 20 abortions for every prenatal care visit and about 200 abortions for every adoption referral based on the approximately 300,000 abortions they perform each year.

Susan B. Anthony List, a pro-life group, has used Planned Parenthood's own figures to determine that abortion represents 94% of all "pregnancy services" rendered by Planned Parenthood.

### Public Opinion

On the second point regarding public opinion, Planned Parenthood relies on polls that simply ask the question whether the organization should be defunded. Given the way in which Planned Parenthood and the willing media have touted the organization's other services, it is natural to expect that some respondents might worry about accessibility to tests or contraception if Planned Parenthood does not provide them.

But no one is suggesting that women's health funding disappear, only that it now go to clinics and organizations that do not perform abortions. And when this is explicitly part of the question, at least one poll shows the public in favor of shifting taxpayer dollars away from Planned Parenthood. The question:

"Congressional Republicans favor shifting Planned Parenthood federal funds to community clinics that perform the same services, but do not perform abortions," the RMU question read. "Would you say you support or oppose this plan?"

53.3% strongly or somewhat supported the plan, while 31.5% were strongly or somewhat opposed. RMU Professor of Political Science Philip Harold commented on the fact these results were different from those of other polls, "One of the cardinal rules in polling is to clearly indicate the alternative in the question and a poll question that doesn't do this is flawed. Because the wording of this poll reflects the actual proposal, it is more accurate." Sadly, but predictably, the media has not done much to disseminate these latest findings.

### Defunding Efforts

As this newsletter goes to print, the Senate has just voted 52-47 to defund Planned Parenthood. The bill, which will now likely be passed by the House of Representatives, would block roughly 89% of federal funding and repeal a number of components of Obamacare, including two provisions that lead to rationing of life-saving care. Funds would be reallocated to community health centers that provide a broader and less-controversial array of women's health services.

President Obama has promised to veto the legislation, but this demonstrates what would be possible with a pro-life president in office.
