

Because there are fewer buses going to the March from Butler County this year, we advise that you call to reserve your seat as soon as possible.

Following a highly emotionally-charged election, we all need to focus on uniting to find support for LIFE. The March for Life will occur one week after the Inauguration and the Pro-Life movement may be under great pressure to find ways to support Respect for Life under a new administration.

However, we also are still dealing with COVID 19 and its possible spread in large gatherings. For this reason, many of our Butler County parishes have chosen not to take buses to the March for Life this year. While we certainly understand these concerns, we are also searching for ways to safely promote Respect for Life at this 48th annual memorial of the legalization of abortion in the United States. Some suggestions:

Legislative Update from PA Pro-Life Federation

2020 marked the year when the PA state legislature successfully passed Senate Bill 857, a telemedicine bill which included a ban on dangerous tele-abortions. These abortions take place when an abortionist is not physically present, but is only available via a computer or phone screen. Unfortunately, Governor Tom Wolf vetoed the bill, solely because of the tele-abortion ban.

We also successfully pressured the PA Health Department to resume inspections of abortion facilities. The Dept of Health website shows that abortion facilities went uninspected for about five months, presumably because of the COVID crisis. After many of you contacted your state legislators, lawmakers wrote letters demanding that the inspections be resumed, as required by law.

In addition, we lobbied for funding for the state's Pregnancy and Parenting Support program, which is administered by Real Alternatives, Inc. This ground-breaking program has served more than 300,000 women and their families and is a model for the rest of the nation.

Election Round-Up

Unfortunately for the pro-life cause, President Donald Trump will not be in the White House come the end of January. President Trump's record on life issues has been rock solid and will be missed. Hopefully, his Supreme Court confirmations will preserve his pro-life legacy.

As this newsletter goes to print, the US Senate remains controlled by pro-life Republicans. Georgia's special January run-off election may change that if the two pro-abortion Democrat candidates defeat the pro-life Republican incumbents. Such a case would give the Democrats control of that chamber, and would require the few pro-life Democrats to stand firm against their party's pro-abortion platform.

Results in the US House of Representatives were more positive. 18 new women backed by the pro-life Susan B. Anthony List (SBA List) were elected to the House this cycle, which may limit Nancy Pelosi's ability to enact her pro-abortion agenda. "The exponential growth of pro-life women in the House is reflective of the fact that life has gone from being viewed as a political problem to a winning issue," remaked SBA List president Marjorie Dannenfelser.

COVID-19 Vaccines

With COVID-19 vaccines appearing on the market, a concern has been raised among Pro-Life groups as to whether tissue from aborted fetuses has been used in the production of these vaccines.

Two questions have been raised:

1. Do any vaccines contain aborted fetal tissue? NO

Some vaccines require the production of viruses, which can only replicate with the help of living host cells. Some of the COVID-19 vaccine candidates are produced using human fetal-derived cells; however, these cells and most of their genetic material are removed during the purification process and are, therefore, not present in the vaccine.

The Astra Zeneca/Oxford vaccine uses human fetal-derived cells for *growing* viruses; the cells are taken from a child aborted in 1972. (Alternatively, living host cells can be obtained from adult stem cells or umbilical cord stem cells.)

- 2. Which vaccines (of those most likely to be available soon in the US) are produced with no cell lines derived from the fetal tissue of aborted babies?
 - BioNTech Pfizer
 - Moderna

Both of these are listed by the Pro-Life Charlotte Lozier Institute as "ethically uncontroversial." However, Children of God for Life compiled research to show that **Moderna** uses aborted fetal cell lines in the fundamental design of mRNA technology, which is the basis for the **Moderna** vaccine.

The difference of opinion seems to come from the fact that, while research connected to aborted fetal cells may have contributed to the knowledge base being used in the **Moderna** vaccine's development, the actual production of the vaccine does not use fetal cells.

Vaccines (cont'd)

Moral Concerns:

We have discussed only the three vaccines most likely to come to public use in the US in the near future. However, there are more than 300 vaccines currently in development around the world to fight the COVID-19 pandemic, with approximately 40 that have advanced to clinical trials. Among these, there are a number that are ethically derived without the use of any cell lines derived from tissues harvested from aborted babies (see sources cited earlier).

The Vatican's Pontifical Academy for Life issued a statement in Italy in 2007 that Catholics could receive vaccines made using human fetal-derived cells, if no alternatives are available. The Vatican states that, in such cases, the recipients of such vaccines should make their objections known <u>and</u> lobby public officials to provide ethical replacements. Thus, the vaccine is received "under protest." Source: Vatican Instruction *Dignitas Personae* (The Dignity of the Person).

However, there are serious questions about the availability of an ethical vaccine for a particular person, in a specific country. For some individuals, there may not be more than one choice of available vaccine. Thus, the moral dilemma arises for an individual.

What Can I Do?

The US Conference of Catholic Bishops, Secretariat of Pro-Life Activities, is recommending that we all contact the US Food and Drug Administration and ask for a COVID-19 vaccine that is free from connection to abortion. This way we can register our "protest" and lobby for the best possible vaccine alternative.
